During the July 26, 2022 regular meeting, Committee member Rebecca Rona achieved consensus to place this item on the August 23, 2022 regular meeting agenda. While the item was not heard that evening, it was carried over to the September 27, 2022 meeting. At the September meeting, an Ad Hoc Communications Subcommittee was created to design flyers for public events and to assemble a list of individuals and various organizations and clubs throughout Culver City.
