the Ad Hoc Subcommittees plays a part in organizing the Fiesta La Ballona event. At the next meeting, it is recommended by staff to appoint Committee Members to the Ad Hoc Subcommittees, add Ad Hoc Subcommittees that the Committee seems fit, and eliminate any Ad Hoc Subcommittees that the Committee feels are no longer necessary.

#### The Role of Ad Hoc Subcommittees

An "ad hoc" subcommittee serves only a limited or single purpose. It is not perpetual, and it is dissolved when its specific task is completed. An Ad Hoc Subcommittee may be formed or dissolved at any noticed during a meeting, as long as the discussion has been placed on the agenda in advance. Once an Ad Hoc Subcommittee has been created, its role is to make recommendations to the associated Commission, Board or Committee (CBC) related to its topic area, only. By consensus of the CBC, a separate agenda item is sometimes prepared and presented on a specific Ad Hoc Subcommittee subject matter.
