BACKGROUND/DISCUSSION

At the October 25, 2022 regular meeting, the EHRAC formed the Nonviolence Workshop Ad Hoc Subcommittee to plan for the upcoming public event, a nonviolence workshop facilitated by Common Peace scheduled for February 28, 2023. At the December 13, 2022 special meeting, the committee agendaized this item to receive a report from the ad hoc subcommittee to discuss, plan, and consider approval of the recommendations for the event. At the January 24, 2023 regular meeting, the subcommittee will provide a report to the full EHRAC.

To note, this public event is a carry-over from the FY 2021-2022 Work Plan.

FISCAL ANALYSIS

There are no costs associated with discussion of this item. There may be associated costs of the event for insurance (if required by Risk Management, which is under review). The Ad Hoc Subcommittee is requesting a budget of \$100 for snacks at the event, and a \$250 honorarium for the workshop facilitator.
