BACKGROUND/DISCUSSION

Public Works Mobility and Traffic Engineering Staff will provide an update regarding the projects to install safety improvements at select signalized and unsignalized intersections.

Safety improvements will be made at 11 unsignalized intersections on Washington Blvd, Sepulveda Blvd, Washington PI, and Higuera St, including addition of intersection lighting, installation/upgrade of

stop signs and other warning and regulatory signs, and upgrade of intersection pavement markings.

Unsignalized Locations

- Higuera St at Kreuger St
- Overland Ave at Northgate St
- Washington Blvd at Kensington Rd
- Washington Blvd at Prospect Ave
- Washington Blvd at Kenyon Ave
- Washington Blvd at Spad Pl
- Washington PI at Boise Ave
- Washington PI at Frances Ave
- Washington PI at Tuller Ave
- Sepulveda Blvd at Vera Way
- Jackson Ave at Farragut Dr/Revere Pl

Safety improvements will also be made at 9 signalized locations. Improvements include new signal hardware, installation of protected left-turn phases, and implementation of leading pedestrian interval (LPI).

- Washington Blvd at Overland Ave
- Culver Blvd at Sawtelle Blvd
- Overland Ave at Braddock Dr
- Overland Blvd at Virginia Ave
- Jefferson Blvd at Hetzler Rd

- Washington Blvd at Inglewood Blvd
- Washington Blvd at Robertson Blvd /Higuera St
