BACKGROUND/DISCUSSION

At its meeting on August 14, 2023, the City Council unanimously (4 - 0) introduced for first reading an ordinance amending CMMC section 7.02.005, to determine and declare updated *prima facie* speed limits on certain City streets. The ordinance is now presented to the City Council for adoption.
