BACKGROUND / DISCUSSION

The 2024 Government Efficiency Ad Hoc Subcommittee was established to continue to implement the City Innovation Award Program to encourage employees and/or departments to contribute towards increased efficiency, improved quality of life for Culver City residents, reduced costs and/or generated revenue, or to demonstrate distinguished performance based on department goals/outcome measures. The 2024 Government Efficiency Ad Hoc Subcommittee is composed of Committee Member Di Vincente, Committee Member Griffing, Chair Lachman, and Committee Member Thakur.

Applications for the City's Third Annual Innovation Awards were due on May 24, 2024. The Subcommittee received 12 applications.
